The Municipal District of Wainwright No. 61 ("MD") invites prices for the loading, hauling and spreading of gravel for the MD's 2026 & 2027 graveling requirements (the "Work"). The Work involves approximately 45,000 metric tonnes and 6,200 miles of hauling for 2026 and a similar amount for 2027. Contractors will be required to complete the 2026 gravel hauling project by September 30, 2026 and the 2027 gravel hauling project by September 30, 2027. Contractors will also be required to provide all equipment necessary to complete this Work. The average haul distance for this Work is approximately 10 - 18 miles.

The Work involves the crush of approximately 173,750 metric tonnes for 2026 and approximately 143,750 metric tonnes for the option year of 2027. Contractors will be asked to supply an oversized jaw for specific locations. Contractors will be required to complete the 2026 gravel crushing project by November 30, 2026 and the 2027 optional gravel crushing project by November 30, 2027. Contractors will also be required to provide all equipment necessary to complete this Work.



- Mobility Infrastructure: Roadway construction, resurfacing, bridge replacement, and emergency access route improvements.
- Range Facilities: Direct Fire Target (DFT) facility/Range Warden building and Range Control building, Infantry Fighting Vehicles (IFV) and tank run-up lanes.
- Support Systems: Refuelling/washing area for IFV/tanks, communication network upgrades, and drainage/service enhancements.
- Environmental & Safety Works: Vegetation management, fence-line clearing, firebreak upgrades, and fence repair/reinforcement where required.

The estimated cost is in the order of \$400,000,000.

It is anticipated that this solicitation will be initiated in January/February 2026. This is conditional on receiving approval to proceed by the Department of National Defence (DND).


